

### Two immediate openings for Housing and Resource Advocates

**Mission Statement:** In collaboration with local partners and all affected by abuse, TTD creates innovative responses and mobilizes our community to promote safety and challenge systems of oppression and violence.

**Job Summary:** The Housing and Resource Advocate is responsible for providing advocacy services and case management to residents of TTD's shelter for victims of domestic and sexual violence, dating violence, human trafficking and stalking. Additionally, the Housing and Resource Advocate is responsible for supporting residents in their efforts to achieve safe, stable housing in a short timeframe, and for working as part of the Residential Services program to enhance the safety and well-being of families in TTD shelter. This position will be based at our shelter in Portland, ME but will include regular work within the community and residential housing. Regular travel throughout Cumberland County required. This is a full-time (40 hours per week, Sunday-Thursday 12pm-8pm, Monday-Friday 9am-5pm and Wednesday-Sunday 12pm-8pm schedules available) hourly position starting at \$15.50 per hour. # **Immediate opening for Shelter Evening Advocate**

**Mission Statement:** In collaboration with local partners and all affected by abuse, TTD creates innovative responses and mobilizes our community to promote safety and challenge systems of oppression and violence.

**Job Summary:** The Shelter Evening Advocate is responsible for, in the evening and/or overnight hours, providing services to residents of TTD's shelter for victims of domestic violence, dating violence, human trafficking, and stalking, and for working as part of the Residential Services program to enhance the safety and well-being of families in TTD shelter. In relation to daytime shelter staff, the evening shift's responsibilities are more focused on safety, and support and connection with residents than on longer term planning. This is a 34-hour per week position with a flexible schedule of 5 nights (both evening and overnight hours) per week totaling 34 hours/week, must be available one weekend night per week. Compensation starting at \$15.50 per hour. TTD offers a generous benefit package for all eligible employees including health and dental coverage, earned time off, sick time, life insurance and pension.

**Job Summary:** The Community-Based Youth Educator is responsible for providing comprehensive prevention, intervention, treatment, and response strategies for children, youth, and young adults and their non-abusing parents or caretakers who are exposed to and/or experiencing dating abuse, domestic violence, stalking, sex trafficking, and/or sexual assault. This position is based at TTD's administrative office in Cape Elizabeth, ME and includes regular work in the Portland High Schools, especially Deering High School. Travel throughout Southern Maine is required. This is a full-time hourly position starting at \$15.50 per hour. Through These Doors offers a generous benefit package for all eligible employees including full health and dental coverage, earned time off, sick time, life insurance and pension.
